

SALES CONDITIONS (extract)

As soon as we receive your 30 % deposit, your option becomes a firm booking.
Your invoice is established on basis of number of participants confirmed 30 days before start of the trip..

Final payment must reach us 14 days before start of the trip.

On final payment, we shall issue the "vouchers" corresponding to all services. They are part of your travel booklet, which will be remitted to you in Reims. In case of last minute booking, should we be able to accept late signatures, the vouchers will be remitted on payment of the whole cost of the trip at one time.

CANCELLATION FEES

Cancellations occurring :

- between 60 and 30 days before start of the trip : 5% penalty on the total amount
- between 30 and 21 days before start of the trip: 30% penalty on the total amount
- between 20 and 10 days before start of the trip: 60% penalty on the total amount
- between 9 and 2 days before start of the trip: 90% penalty on the total amount
- Less than 48 hours before start of the trip, or no show : 100 % penalty on the total amount

The day of reference for the calculation of penalties is the date mentioned on the registered cancellation letter or e-mail.

Conditions of Sales

ACITA is a limited liability company, registered in the trade register of Vannes (France) under the Number B3800705731. It has a share capital of 18294 Euro. Company headquarter is Vannes, under the address Parc d'Innovation de Bretagne Sud (P.I.B.S.), C.P. 30 in 56038 Vannes Cedex. ACITA is the owner of the licence number Li 056.95.002, insured through AXA and guaranteed through Association Professionnelle de Solidarité des Agences de Voyages. Atlantica International and Atlantigroupes are registered trade marks of the enterprise ACITA. The activity of Atlantica International is the organization of Incentive trips for Enterprises, whereas the activity of Atlantigroupes is the organization of classical group voyages. The activities of the travel agencies are fixed by the law number 92 - 645 from the 13th July 1992 and by the decree number 94 - 490 from 15th of June 1994. The general sales conditions fixing dealings between the travel agencies and their clients are regulated by a Minister decision from 22nd November 1994.

ACITA informs clients about the fact that each reservation of a program implies automatically the acceptance of the general sales conditions, fixed by above mentioned Minister decision and law, as well as the acceptance of the special terms of the respective programs. Each controversy, which cannot be resolved, is affair of the district court of Vannes.

The main activity of ACITA is the creation and organization of tourism products (trips, round trips, stays) for groups. This concerns also the selection of the service providers, the administration for customer's account of the options and reservations, the supply of all inclusive programs, their permanent quality control and the assistance during the journey.

Prices

Our prices are package prices.

Concerning catalog products, the description and tariff give details of all services included .. Our group prices refer to a minimum basis of 20 paying participants. Under 20 participants, the individual price will be automatically applied.

Excepted if specifically agreed, the following elements are not included :

- insurances : cancellation, repatriation, luggage loss,
- Portage and tips
- personal expenses and additional activities, which are not contained in the price
- drinks during meals (half board or full board)
- additional meals not foreseen of the full or half-board
- activities, which are presented as possibilities or suggestions or options in the program

Concerning "tailor made" products, they are established on request, quoted specifically, and described in a personal contract indicating with precision all services included.

Subject to re-evaluation in case of variation of price of oil barrel affecting transport costs.

Reservation and payment

The reservation is effective after pre-payment of a deposit.

- Deposit : 30 % on the basis of expected number of participants for a firm reservation
- Saldo of the invoice 2 weeks before the arrival of the clients

The invoice is established on the basis of the final number of participants which has to be transmitted to the Travel Agency 30 days before the beginning of the voyage. Payment has to be made at least 14 days before the beginning of the journey. The client receives a *carnet de voyage* containing the vouchers for each activity, which have to be handed out to the respective service providers. In the case of a late reservation or a "last-minute" reservation, total payment has to be carried out on the day of inscription.

Cancellation fees

- In case of global cancellation , up to 31 days before arrival of the group : 5 % of the deposit is not refundable, according to sales conditions of the hotels and various services booked, and in view of work already done for the elaboration of program by the Travel Agency.

- between 30 and 21 days before arrival: 30% of the total price
- between 20 and 10 days before arrival: 60% of the total price
- between 9 and 2 before arrival: 90% of the total price

- less than 24 hours before or No show : 100% of the total price the number of days starting from the day when we receive written cancellation by e-mail or fax.
- In case of partial cancellation, up to 31 days before arrival of the group : same rate (20 %) is applied to individual price for every person who cancels, as long as the group remains equal or superior to 20 persons and is maintained.
- If the group becomes inferior to 20 and is maintained on Customer's wish, prices have to be re-calculated.

If, in case of unforeseeable events of *force majeure* or for the guarantee of the security of the customers or in case of interruption of maritime traffic due to the weather, Acita is compelled to cancel the program or part of it, the agency will make all possible efforts to replace the program by an equivalent service at the same quality level.. A reimbursement or financial compensation is however impossible.

Alterations

The accurate number of participants as well as rooming list must be received by Acita at least 4 weeks before travel beginning. In case of increase of the number of participants after this date, Acita will strive to make the additional reservations. In case of decrease of the number of participants, then the cancellation conditions will be applied.. Each change in the dates and/or nature of program implies an additional cost of 40 Euro per modification.

Assurances

We are at your disposal for supplying all types of insurances, but recommend that this point is arranged from your departure town.
